

# "Pass the Power" Promotion Regulations

The following regulations define the rules of the "Pass the Power" promotion within the BeActive Program Account.

#### Article 1. Definitions

- Entry pass means a Comfort/Open monthly pass or Comfort/Open three-month pass.
- **Card** means a subscription card or any other form of substitution that enables the User to use the services covered by the BeActive Program.
- Account means an individual panel for each Reference, activated for his/her benefit by the Operator, according to the rules specified in the BeActive Regulations.
- Link individually generated and assigned to the Reference the link to the platform's website within the BeActive Program.
- Operator means Instytut Rozwoju Fitness sp. z o.o. with its registered office in Warsaw (02-801), ul. Puławska 427, NIP (Tax Id. Number): 7010352371, REGON (National Business Registry Number): 146273733, entered into the register of entrepreneurs of the National Court Register kept by the District Court for the Capital City of Warsaw in Warsaw, XII Commercial Division of the National Court Register under the KRS number: 0000431424; e-mail: info@ebeactive.pl,
- Reference means a BeActive account holder who provides a personal link generated by the platform's website to an Invited Person, allowing the Invited Person to purchase an Entry Pass at the price specified in the Table of points and types of passes in Article 3 point 1 of the Regulations.
- Partner means an Entrepreneur, separate from the Operator, who provides the Users with services covered by the Program under an agreement with the Operator.
- -Platform means the website maintained by the Operator at the address: www.ebeactive.pl.
- BeActive Program/Program an offer for users to use the Partner's network of

sports and fitness facilities based on the Card and under the conditions specified in the BeActive Regulations.

- Entrepreneur means a natural person, a legal entity or an organizational unit that
  is not a legal entity, to whom legal regulations grant legal capacity, conducting in its
  own name a business or professional activity which can be used by the User within
  the scope of the Program.
- **Invited Person** means a person not registered in the BeActive Program who has purchased an Entry Pass using a link provided by the Reference.
- BeActive Regulations means the regulations defining the general conditions, rules and manner of sales conducted by the Operator, through the platform's website, the rules of using the Cards by the Users as well as the terms and conditions of providing electronic services by the Operator.
- Promotion Regulations means these Regulations of the "Pass the Power" promotion.
- -Platform's website means websites at which the Operator runs the Platform, operating under the domain: <u>www.ebeactive.pl.</u>
- User means a natural person aged from 18 to 26 years, having full legal capacity, being a pupil or a student, having a valid school or student ID card, using the Program, Cards or Platform to the extent not directly related to its business or professional activity.

### Article 2. General provisions

- 1. The Reference can provide the Invited Person with an individually generated Link via the BeActive platform website, which allows the Invited Person to purchase an Entry Pass for the network of sports and fitness facilities of the Program Partner.
- 2. If the Invited Person purchases an Entry Pass, the Reference receives a certain number of points, which are credited to the Reference's Account in the "Pass the Power" tab of the Account.
- 3. The number of points recorded in the Account of the Reference depends on the type of the Entry Pass purchased by the Invited Person.
- 4. In exchange for a certain number of points collected under the "Pass the Power"



- promotion, the Reference receives a monthly OPEN pass for using the network of sports and fitness facilities of the Program Partner.
- 5. The minimum number of points in exchange for which the Reference receives a monthly OPEN pass is 1000 points.
- 6. Points can only be credited to the Reference if the next Invited Person, not yet registered in the BeActive Program, purchases an Entry Pass. It is not possible to award points in exchange for the purchase of another Entry Pass by the Invited Person (extension of the Pass) who has already purchased an Entry Pass using the Link.
- 7. The Invited Person can use the Link provided by the Reference only once. Any subsequent use of the Link will not be scored as part of the "Pass the Power" promotion.
- 8. If the Invited Person has opened the Link provided by the Reference and then failed to purchase the Entry Pass, points are allocated to the Reference only if the Invited Person has purchased the Entry Pass within 30 days of the opening of the provided Link using the BeActive program website.
- 9. The Reference has access to the list of Invited Persons and the number of awarded points, which is displayed in the "Pass the Power" tab after logging in to the platform's website.
- 10. The Reference, after obtaining the minimum number of points, can collect the monthly OPEN pass, making an order in the purchase form on the website: www.ebeactive.pl.
- 11. In order to use the obtained points, in the payment option, select the "POINTS" item. The obtained points will be collected from the Reference's Account.
- 12. The Reference may continue to collect points, even after they have been exchanged for an OPEN pass, until the end of the "Pass the Power" promotion.
- The terms of use of the platform's website are set out in the BeActive Regulations, available at <u>www.ebeactive.pl.</u>
- 14. The list of partners participating in the Program is available at www.ebeactive.pl.
- 15. The "Pass the Power" promotion of the BeActive Program is valid from 18 July 2014 until further notice.

#### Article 3. Special provisions

1. Table of points and types of passes:



Pass type	Pass price	Points
1M Comfort	59.00	100
1M Open	99.00	150
3M Comfort	159.00	200
3M Open	269.00	300

- 2. The prices presented in the above Table are gross prices in the currency valid in the territory of Poland (PLN).
- 3. "1M" means a one-month pass and "3M" means a three-month pass.

## Article 4. Final provisions and amendment of the promotion Regulations

- 1. The Reference, who passes the Link to Invited Persons, accepts at the same time the content of these promotion Regulations.
- 2. The content of these Regulations may be recorded by printing, saving on a data carrier or downloading at any time from the platform's website.
- 3. The promotion Regulations are subject to change. Each User shall be informed about the content of amendments to the promotion Regulations by placing the information about the amendments to the promotion Regulations on the main page of the platform, with an option for redirecting the user to the information containing a list of amendments to the promotion Regulations and maintaining this information on the main page of the platform for at least 14 (fourteen) consecutive business days, as well as additionally sending the information containing a list of amendments to the promotion Regulations to the e-mail address indicated by the User in the registration form.

Informing about the amendments to the promotion Regulations in the manner specified above shall take place no later than 14 (fourteen) working days before the introduction of the amended promotion Regulations. If the User does not accept the new content of the promotion Regulations, he/she is obliged to notify the Operator of this fact by the day preceding the entry into force of the amended promotion Regulations. The lack of acceptance of the Regulations by the User results in the lack of possibility to use the "Pass the Power" promotion.
